The Nicollet County Board of Commissioners met in regular session on Tuesday, September 13, 2022, at 9:00 a.m. Commissioners Marie Dranttel, Jack Kolars, Terry Morrow, John Luepke and David Haack were present. Also present were County Administrator Mandy Landkamer, County Attorney Michelle Zehnder Fischer and Recording Secretary Sarah Frahm.

Approval of Agenda

Motion by Commissioner Haack and seconded by Commissioner Luepke to approve the agenda. Motion carried with all voting in favor.

CSAH 13/Lookout Drive Corridor Study Update - Ross Tillman, MAPO

Ross Tillman, Project Engineer at Bolton & Menk, shared a presentation with updates on the CSAH 13/Lookout Drive corridor improvement study.

Consider Award of Bid for SAP 052-615-025 (CSAH 15 Reconstruction Project)

Director Greenwood presented the three bids opened on August 23, 2022 for the CSAH 15 reconstruction project. Director Greenwood recommended approval of the lowest bid by Mathiowetz Construction.

Consider LRIP Grant Agreement No. #1051372, Resolution, and Property Certification

Motion by Commissioner Morrow and seconded by Commissioner Kolars to approve the LRIP Grant Agreement No. 1051372, Resolution, and Bond Financed Property Certification. Motion carried with all voting in favor on a roll call vote.

Consider Award of Quote for CP 15-22 (CSAH 15 Culvert Repairs)

Director Greenwood presented the three bids opened on September 12, 2022 for the CSAH 15 culvert repair project. Director Greenwood recommended approval of the lowest bid by PCIRoads, LLC.

Motion by Commissioner Luepke and seconded by Commissioner Kolars to award project CP 15-22 to PCIRoads, LLC. Motion carried with all voting in favor on a roll call vote.
